



The Department of Health and Human Services (DHHS) is the lead agency responsible to plan and administer child care subsidies funded by the Child Care and Development Block Grant (CCDBG). This work is done by the Child Care Affordability Program (CCAP), in the Office of Child and Family Services (OCFS) https://www.maine.gov/dhhs/ocfs.

The Child Care and Development Block Grant (CCDBG) Act of 2014 enhances statutory development and school success; and supports parents who work or are in training or education. The CCDBG Act also supports parent and family member involvement in the development of their children in child care settings. As the lead agency, Maine DHHS assists this effort by sharing consumer education details about child care services to parents and families to help them make informed choices.

# The Child Care Affordability Program (CCAP):

The CCAP is a statewide program that supports eligible families to pay child care.

### The Child Care Affordability Program:

- Helps eligible families pay for child care if they work, go to school, attend a job training program, or are retired and the legal guardian of a child;
- Ensures the health and safety of children in child care;
- Provides equal access to high quality child care for families with low income; and
- Enhances the quality of child care and the Early Care and Education workforce.

**Note:** Do not bring your completed application to a DHHS Office.

### OCFS staff will review your application to:

- Determine if you are eligible for the program; and/or
- Approve the child care provider you chose.

### Important CCAP Income and Eligibility Guidelines:

- All families must meet income guidelines at or below one hundred twenty five (125%) of the State Median Income.
- ❖ Add three percent (3%) for additional family members. The total amount of assessed fees to a family shall not exceed ten percent (10%) of the family's gross income for all their children.
- Fees are assessed to all families. The parent fee is determined by the:
  - o Number of individuals in the family;
  - o Gross income or if self-employed, allowable net income; and
  - o Quality Rating and Improvement System (QRIS) level of the Early Care and Education Program.
- The parent fee does not vary with the:
  - o Number of children receiving child care services;
  - o Amount of child care services they need; or
  - o Type of child care services the parent chooses to use.
- Weekly fee assessments must be rounded down to the nearest dollar. All assessed parent fees shall be paid directly to the provider by the parent. - Parent(s) enrolled in job training, or an educational program must prove enrollment the first time they fill out an application and when redetermined. They must attend classes in person or online.
- ❖ If a parent is income eligible and provides documents from the Social Security Administration (SSA) or the MaineCare Medical Review Team, identifying a disability that makes them: 1) unable to take care of the child(ren); or 2) unable to work and the other parent is working, attending a job training or education program, the family may be eligible for the CCAP.
- ❖ If a child is home-schooled, the parent is not eligible to receive child care subsidy during regular school hours, as defined within their school district.
- ❖ If funding is available, DHHS may waive the employment, job training or educational program requirements; and approve CCAP for no longer than twelve (12) months, for: o At-risk children:
  - o A child involved in an open child protective case;
  - o A child in care and custody; or
  - o A child placed under the legal quardianship of a person who is at retirement age.

# **Client Income Eligibility Criteria**

Individuals eligible for the CCAP from the Maine Department of Health and Human Services must comply with income eligibility criteria below.

### **Background Checks and Child Care Providers**

To meet federal and state requirements for all Child Care Providers delivering direct child care services, OCFS conducts a criminal background check, that includes fingerprinting. There is no cost to child care providers for this process. Child Care Providers are required to request background checks with the use of fingerprinting for themselves and their child care staff member(s) to include:

- All licensed child care facilities;
- Licensed family child care providers; and
- CCAP license-exempt child care providers (excluding CCAP relative child care providers).

Per Federal law (45 C.F.R. § 98.43) the following individuals must submit to background checks with the use of fingerprinting described below:

- All adults (18 years and older) residing in the location where child care services are being provided;
- Any individuals whose activities involve the care or supervision of children or who have unsupervised access to children; and
- The Child Care Provider him or herself.





The following registries, repositories, and databases are checked for each individual for whom a background check is requested, with the mandatory use of fingerprints described below:

- ❖ National Crime Information Center National Sex Offender Registry <a href="https://www.fbi.gov/services/cjis/ncic#File-Types">https://www.fbi.gov/services/cjis/ncic#File-Types</a> and Federal Bureau of Investigation fingerprint check (using Next Generation Identification).
- In the State where the individual resides: State child abuse and neglect registry/database, State Bureau of Identification (SBI) <a href="https://www.maine.gov/dps/msp/about/sbi">https://www.maine.gov/dps/msp/about/sbi</a> crime repository with fingerprints, and State Sex Offender Registry <a href="https://www.nsopw.gov/">https://www.nsopw.gov/</a>.
- ❖ In each State where the individual has resided at any time during the previous five (5) years: State child abuse and neglect registry/ database, SBI or comparable State agency's crime repository (with or without fingerprints), and State Sex Offender Registry.

Individuals must schedule an appointment for fingerprinting. All individuals must complete the above requirement every five (5) years. Once completed, individuals will receive a letter from the OCFS stating whether individual is eligible or ineligible **and** a letter to provide to current or prospective employers.

If you who do not receive your eligibility letters by mail within twenty-one (21) calendar days of your completed fingerprint appointment, please call (207) 624-7903 or email <a href="mailto:childcareoosbgc@maine.gov">childcareoosbgc@maine.gov</a>. You will need to provide your name, date of birth, and the Transaction ID number from your appointment.

- An adult who provides care in their own home;
- ❖ An adult who comes to your home to provide care; and
- ❖ A relative over 18 years of age.





# Process for Licensing Child Care Providers: Children's Licensing and Investigation Services (CLIS)

CLIS ensures Early Care and Education Programs are safe and healthy environments, provide care and supervision, and engage in developmentally appropriate activities to meet each child's physical and emotional needs. CLIS monitors compliance with regulations set by the DHHS under direction of the Maine Legislature. CLIS licenses and monitors: Family Child Care Homes, Child Care Centers, and Nursery Schools. # **Monitoring and Inspecting Child Care Providers**

CLIS provides monitoring inspection reports for each on-site visit to **licensed** and **license-exempt** Early Care and Education Programs. This report outlines any health and safety violations and includes action step(s) the child care program took to correct the violation(s).

- Mandated Reporters are individuals required by law to identify suspected child abuse and neglect quickly enough to avoid serious and long-term damage to a child. Professionals who frequently meet children in their work are in the best position to recognize and report suspected child abuse and neglect. The OCFS runs the child abuse and neglect statewide hotline. Mandated Reporters call this hotline to make a report. Staff guide callers through the process of making a report of suspected abuse and neglect. The hotline is available 24 hours a day, 7 days a week.
